Elizabeth**: Mr. Speaker I beg after the approval of the Education, Vocational Training and ICT on the Baringo County pre-school and early childhood Bill 2020 by the County Assembly, the committee is charged with the responsibility of introducing this Bill in this House. We found that this was a good Bill that will assist when certain group wants to establish an ECDE center in respective areas. We should pass this Bill to enable early childhood growth and enhance learning, thank you Mr. Speaker and request Hon. Cornelius to second.

Child means an individual who has not attained the age of eighteen years;

Curriculum means all the approved subjects taught or programs offered and includes all the activities provided at any institution of basic education;

Parent/guardian means a mother, father or guardian of a child and includes any person who is responsible under the law to maintain a child or is entitled to a child's custody

Special needs education includes education for gifted or talented learners as well as leaners with disabilities and includes education which provides appropriate curriculum differentiation in terms of content, pedagogy, instructional materials, alternative media of communication or duration to address the special needs of learners and to eliminate social, mental, intellectual, physical or environmental barriers to learners;

Sponsor a religious institution whose duty is to uphold the religious traditions of the school and always give spiritual guidance to the children and the teachers.

  - (c) Will come into effect when we have a policy at committee level.

Secondly, has the committee consulted with the ministry on the new curriculum CBC to the current ECDE? We might pass such Bill but it gets obstacles in its implementation stage. I challenge the owner on this. I will be the first member to champion this Bill when it is implemented in our locality, thank you.

Part III of the Bill provides for registration of schools, centers and other institutions within the County

Part IV of the Bill provides for miscellaneous provisions to include; administrative and technical costs, how the public may institute complaints, publications of matters of concern to the community and other subsidiary regulations that is what the Bill entails, thank you.

I beg to move that the committee do report to the House its considerations of the Baringo County Pre-Primary and Early Childhood Bill 2020, Baringo County Assembly Bill No. 05 of 2020 and its approval thereof with amendments.
