The Temporary Speaker (Hon. Lemlem): Hon Members welcome to our session, I can see members are consulting please do so in low tones.

STATEMENTS

INVENTORY AND DISPOSAL OF COUNTY MACHINERY AND EQUIPMENT

The Temporary Speaker (Hon. Lemlem): There is a statement 005/2021 by Hon. Paul Serem MCA Lembus Perkerra Ward to the Chair Transport, Public Works and infrastructure committee. Vice Chair to that committee, Hon Musa Cheruiyot, Member for Koibatek Ward.

Next statement 007/2021 by Hon Paul Serem to the chairman Housing and urban development committee. Chair. I can see both the chair and the vice are not here. Any member of that committee. The Deputy Leader of majority Hon Parsalaach.

DEMARCATION/PLANNING OF CENTRES IN EMINING

The Temporary Speaker Next statement by Hon Paul Kibarar MCA Emining Ward to Chairperson Lands Housing and urban development and this being a new statement welcome Hon Kibarar.

Hon. Kibarar: Mr Speaker I rise to see a statement from the Chairpeson Lands, Housing and urban development committee on the following matters of concern:

- 3. What is the status of the centres below in terms of demarcation and planning namely Kamara, Emining, Cheberen, Kimose, Radad and Maji Moto respectively
- 4. What action does the department of lands housing and urban development put in place to ensure that all market centres in the county are properly demarcated, planned and classified accordingly.

The Temporary Speaker (Hon. Lemlem): Thank you Hon Member. Hon. Birchogo what is the concern. Hon Birchogo this being a new statement and you seem not to have any concern, Hon Member for Ilchamus Hon Parsalaach can you also give a commitment on this.

Hon. Parsalaach: This being a new statement we will require about two weeks so that we can provide and answer.

The Temporary Speaker (Hon. Lemlem): Thank you very much. That will take us to 29th of April 2021 same time like today. Hon. Birchogo what is your issue?

Hon. Selemoi: Mr Speaker with due respect to our standing orders and rules of the game sis it in order first of all for you to be taken in circles and being taught on how to transact the business. Secondly the information I was rising on, every Thursday on our calendar we do have statement hour so I want because these are Hon Members who deserve to be heard can you rule that we go into that session so that we ventilate what the Hon Members will want to engage because as it is now it is in order for us to debate on any other matter without any standing of the law and it is your prerogative.
