Hon. Elizabeth: Thank you Mr. Chair I have a concern in D3009 department of lands housing and urban development on disaster preparedness. We have a lot of disasters in our county yet they have allocated little money of Kshs. 1, 200,000. This is a crucial department and need more funds to mitigate upcoming disasters. In the coming supplementary budget, it needs to be allocated more money. Secondly, the department of civic education is a devolved function to the counties also it needs a lot of funding. Thirdly, we have lost many cases in courts due to minimal allocation of money to county attorney and the budget committee should next time ensure that, that office gets enough money so as to represent the county cases well. Thank you.

The Chairman (Hon. Kimosop): Thank you member I need to clarify something on supplementary budget that if we pass it, its live ends on 30th June 2021 less than three weeks from now. We can only align on what we can spend in the three weeks that are remaining. I followed yesterday with the treasury and there is a probably requisition to be paid next week then we can have the last requisition. The committee is only harmonizing what is due for payment on 30th June otherwise we will have entire budget. Your allegations are true we should be critical on our budget lines. Mover,

That capital expenditure for vote D3010 department of agriculture, fisheries, veterinary and livestock be amended by increasing Kshs. 856,000 from Kshs. 519,329,330 to read Kshs. 520,185,330.

That the capital expenditure allocation for vote D3011 department of water and irrigation be amended by reducing Kshs. 7,665,040 from Kshs. 694,062,407 to read Kshs. 686,397,367.

That class Sub-total DE be amended by increasing Kshs. 44,351,960 from Kshs. 3,216,719,312 to read Kshs. 3,261,071,272.
