018/2025: Hon. Linah Sote MCA, Baringo County, seeks a statement from the **Chairperson, Transport, Public Works and Infrastructure Committee** on the following matters of concern;

THAT, most streets and major roads within Kabarnet town are dark owing to lack of streets lights causing fear and insecurity to business community and the general public.

012/2025: Hon. Jeruto Kiptalla, MCA, Baringo County, seeks a statement from the **Chairperson, Health Services Committee** on the following matters of concern:

THAT, health is a fully devolved function with mandate to address all matters health for a healthy county and society.

Kimoso dispensary was completed and no nurse has been posted to the facility:

- i. Are there plans to open and operationalize Kimoso dispensary? and if yes when?
- ii. How much has been used to build the dispensary?
- iii. What is the registration status of the facility i.e. resource allocation, medicine supply and SHA compliance?
- iv. What plans has the County Government put in place to ensure that Kimoso dispensary is fully equipped and adequately staffed in order to begin rendering services to serve the people?

019/2025: Hon. Linah Sote, MCA, Baringo County, seeks a statement from the **Chairperson, County Heritage, Gender, Culture and Community Services Committee** on the following matters of concern;

THAT, article 53 (1) of the constitution of Kenya provides for the Rights of every child that include the right to free and compulsory basic education, basic nutrition, shelter and health care.

FURTHER, the Menstrual hygiene policy 2019-2030 aims to ensure women and girls can manage menstruation hygienically, freely and with dignity, providing access to information, menstrual product, services and facilities as well as waste disposal.

AWARE THAT, lack of sanitary products affects the education and learning for the girls as it may prevent them from attending school and distract them from achieving their educational dreams.

CONCERN THAT, poverty and lack of Sanitary towels may lead to early childhood marriages and teenage pregnancies;

- i. What plans has the County Government put in place to ensure that school going girls are provided with sanitary towels having in mind that many children come from humble backgrounds; others are orphaned and may not afford to acquire the basic product.
- ii. Has the County Department allocated funds aimed at purchasing the sanitary products? If yes, how much was allocated?
- iii. What has the County Government done in terms of legislation to facilitate access to sanitary materials by girls, fight against the Gender Based Violence (GBV) and promote girl child welfare in the County?
