6. NOTICES OF MOTION HON. SHARON KETTER, MCA, BARINGO COUNTY

Hon. Speaker, pursuant to Standing Order 46, I beg to give Notice of the following Motion:

AWARE THAT, Article 29 of the Constitution provides that every person has the right to freedom and security of the person, which includes the right not to be deprived of freedom arbitrarily or without just cause;

ACKNOWLEDGING THAT, the Constitution of Kenya, in Article 53 (1) (b) state that every child has a right to free and compulsory basic education and Article 55 (a) the State shall take measures, including affirmative action programmes, to ensure that the youth access relevant education and training; NOTING THAT, bandit attacks in areas in Baringo County have led to displacement of people where they have been forced to make do with makeshift schools in a bid to ensure education continues where in the makeshift schools, pupils learn under trees with no roof above them;

CONCERNED THAT, the anguish caused by these bandit attacks has led to many pupils missing school for long periods thus disadvantaging them against their colleagues yet they are supposed the same exams for primary and Secondary Schools;

DISTURBED THAT, most of the pupils and students of these bandit prone areas h ave lost their bread winners, their livestock stolen leading them to continue wallow ing in abject poverty and end up in dropping out of school due to lack of school fe es and other basic needs;

FURTHER DISTURBED THAT, most of these pupils who have lost their bread winners and kin and livestock have sunk into depression and are traumatized due the horrific incidents they encounter due to these bandit attacks;

NOW THEREFORE, this Motion urges the County Government to;

- i. Look for mechanisms to ensure that these children who have lost their bread winners are prioritized while issuing bursaries;
- ii. Ensure that rescue centers are put up and that these traumatized children are taken there for among others get psychological support especially guidance and counseling to enable them erase these horrific memories.

THAT, the people of Koroto in Saimo Soi Ward have been enjoying health service s offered at Koroto dispensary from the time it opened its doors to the Public. Concerns has been raised however after services were indefinitely disrupted from 2024 due to the exit of the resident nurse without a replacement.

- i. Is the Department of Health Services aware that the said dispensary has been operating without a substantive replacement of the nurse who left and has been relying on a volunteer since then?
- ii. What is the Department doing to ensure that there is a substantive replacement of the nurse who left the said facility?
- iii. What is the state of supply of essential drugs to the said facility?
- iv. What plans has the County Government put in place to ensure that health services in any County facility are not disrupted due to unaddressed personnel or operational issues going forward?

HON. NIXON LEMLEM, MCA, MARIGAT WARD

AWARE THAT In Kenya, the right to property is constitutionally protect ed under Article 40 of the Constitution of Kenya, 2010. This guarantees every person the right to acquire and own property, individually or in association with others, of any description, and in any part of Kenya.

APPRECIATIVE of Article 43 of the Constitution which outlines various socio-economic rights, including the right to a reasonable standard of living. This right can be interpreted to include the right to live in a safe environment, which would encompass protection from hazards like fire.

FURTHER NOTING THAT, County Governments in Kenya play a crucial role in protecting property from fire through various measures, including promoting fire safety, providing fire and rescue services, and implementing fire prevention strategies.

ALARMED THAT recently, there was a fire outbreak in Marigat town razing do wn entire business and residential plots without any visible county rescue team and further several fire incidents have been reported around Marigat ward and the entire Baringo County at large;

NOW THEREFORE; this Motion urges the County Government of Baringo to

- 1) Explain how the County Government is prepared in tackling fire incidences when they occur;
- 2) State how many fire engines and fire training personnel are on standby and ready when these incidences happen?
- 3) How are the fire stations and engines distributed in the county in readiness for any eventuality of fire tragedies?
- 4) How is the County Government planning to compensate the victims of fire tragedies?
