- i. If he is aware that during the 2017/2018 Financial Year, ten plastic water tanks of 10,000 litre capacities were budgeted to be bought for ten (10)Tirioko ward ECDE centres?
- ii. If he is further aware that the ten Tanks were to be distributed to the following ECDE centres namely:

 - b) Chemayes ECDE
 - c) Dira ECDE
 - d) Kangiruru ECDE
 - e) Kreze ECDE
 - f) Chischis ECDE
 - g) Katagh ECDE
 - h) Loyamoi ECDE
 - i) Chepkirial ECDE
 - j) Kamurio ECDE
- iii. Can the Chairperson confirm if the said tanks actually reached the intended ECDE centres?
- iv. Can the Chairperson without the use of signed list from the department table before this Honourable House the acknowledgment and or receipt letters of the

said tanks from each of the intended ECDE centres with photographical evidence on the availability of the said tanks in each of the listed centres?

v. What measures is the County Government taking to ensure that the said tanks are availed to the respective ECDE centres?

- i. If she is aware that there were health workers recruited under Universal Health Care (UHC) programme in June and July 2020 in Baringo County?
- ii. If she is further aware that all the staff recruited in the two phases have since reported to work?
- iii. How many staff were recruited in each phase in terms of gender and the Sub-county they come from?
- iv. Can the chairperson provide the list of all the recruits in UHC 1 and UHC2 per cadre per Sub-county indicating the year of college completion?
- v. The chairperson to provide further the list of deployment per Sub-county and specific health facility the recruits are attached to?

AWARE THAT, the Constitution of Kenya as stipulated under Article 27(3) provides that women and men have the right to equal treatment, including the right to equal opportunities in political, economic, cultural and social spheres,

ACKNOWLEDGING THAT, Baringo County Revenue Clerks are operating under deplorable working conditions evidenced by poor attires they don while undertaking their responsibilities,

NOTING THAT, there is little or no motivation to the Revenue Clerks yet they play a vital role in ensuring the County Government realizes its revenue targets,

CONCERNED THAT, there are inadequate number of Revenue Clerks in the County who coupled by the fact that there is no gender balance among the existing number of Revenue Clerks,

DISTURBED THAT, there is no proper training of Revenue Clerks coupled by little or no knowledge of digitalization of the revenue collection,

NOW THEREFORE, this Motion urges the County Government to:

1. Provide proper attire to ensure the Revenue Clerks dress properly while undertaking their daily duties,

- 2. To provide this House with the number of Revenue Clerks currently employed by the County Government.
- 3. Ensure that the Revenue Clerks are motivated and conduct periodic trainings so as to bolster their knowledge on revenue collection by embracing technology.
