- ii. Which projects were funded using the above balance?
- iii. Was public participation done to authorize the re-allocation of the above balance?

047/2024: Hon. Paul Lolgisoi, MCA, Mukutani Ward, seeks a statement from the **Chairperson, Finance and Economic Planning Committee** on the following matters of urgent concern:

THAT, the County experienced adverse effects of climate change including but not limited to flash floods that swept away hundreds of hectares of farmers crops, led to massive loss of livestock, destroyed many homesteads and important public infrastructures like roads, bridges and schools. Many people were also displaced.

Further, the County Government while planning for disaster mitigation interventions justifiably sought an increase of funds for emergency from the allocated Kshs. 23 million to Kshs. 100 million in the First Supplementary Budget for the 2023/2024 Financial Year; a proposal that was approved by the County Assembly.

- i. Why is it that the Kiserian footbridge has not been restored to its requisite functionality despite funds for disaster being availed as it remains submerged to date?
- ii. Why have the following roads and culverts not been repaired after being damaged by flash floods?
 - a) Kailer – Loitip – Sirata road.
 - b) Sirata – Chemorongion road.
 - c) Kiserian - Noosukuro road.
- iii. What are the reasons for failing to supply Noosukuro community who have been marooned by the flood waters with food and non-food

items as part of disaster mitigation despite being the supposed beneficiaries of the budgeted funds?

- iv. What measures has the County Government put in place to ensure that the matters raised above are resolved expeditiously to ensure that the affected residents and communities within Mukutani Ward are assisted to avoid any marginalization?

(The Committee to liaise with the department and provide a full report on 16th October, 2024).

048/2024: Hon. David Sitoi, MCA, Bartabwa Ward, seeks a statement from the **Chairperson Finance and Economic Planning Committee** on the following matters of concern;

THAT, Article 196, 201(a) of the Constitution of Kenya 2010 provides for public participation;

THAT, the County Executive Committee Member responsible for Treasury and Planning is mandated to lead the Annual Development Plan (ADP) and the Annual Budget for the County.

THAT, during the 2023/24 FY, the following projects, totaling **Kshs. 8, 137,500** were well identified in the ADP and subsequently allocated budgets for by the residents of Bartabwa Ward.

- a) Construction of Bukwo and Beibosok foot bridges **Ksh.3, 000, 000,**
- b) Fuel for dozing works, **Ksh.2, 000,000**
- c) Construction of Kapturo Dispensary staff houses **Ksh.1, 175,000**
- d) Drilling of Kokwomoi borehole, **Ksh.1, 300,000**
- e) Pipeline extension for Terik borehole, **Ksh.662, 500**

Additionally, the said projects have not been implemented and have not been included in the 2024/2025FY, as shelved or rolled over projects.

- i. Can the County department of Finance & Economic Planning confirm that these projects were in the 2023/24 FY Budget, and if yes, confirm that the projects were not implemented?

- ii. If the aforementioned projects were not implemented, can the department give reasons why they were not included in the 2024/25 FY Budget?
- iii. What measures will the department put in place to ensure that projects are not lost during the implementation stage?

THAT, there is an outbreak of Hepatitis B in Kabarnet Ward in areas of Salawa and its environs;

- i. What measures is the County Government putting in place to facilitate the screening of residents of these areas to avert a looming health crisis as a result of the outbreak of this deadly disease?
- ii. What plans does the department have to facilitate the vaccination process of the residents in these areas against the disease?
- iii. What measures is the County Government taking to initiate the process of sensitizing the residents on the symptoms, causes and treatment of Hepatitis B?

(The answer was not satisfactory. The committee should take note of the statistics and clarify the distribution of results for Tiaty East and Tiaty West)

046/2024: Hon. Daniel Tuwit, MCA, Ribkwo Ward, seeks a statement from the **Chairperson, Agriculture, Livestock and Fisheries Committee** on the following matters of concern:

THAT, livestock is a source of livelihood in most parts of Baringo County especially Tiaty, Baringo North, Baringo South and Mogotio Sub-Counties and cognizant of the fact that livestock is a source of revenue to Baringo County Government

AWARE THAT, during the rainy season, outbreak of diseases that include; East Coast Fever, Foot and Mouth, Anthrax and Lumpy skin is widely experienced;

- i. What has the department done to identify the diseases?
- ii. What has the County Government done to make sure that the animals are vaccinated and healthy?
- iii. How much funds has been set aside by the department for the said vaccination?
- iv. Provide schedule/ programme of vaccination across the County; give
 - a. The areas where vaccination was done;
 - b. The dates of vaccination;
 - c. The personnel involved in the activity;
 - d. The type of disease vaccinated
- v. Is the County Government aware of insurance of Livestock undertaken by private entities in Kibingor Marigat ward?
- vi. Is there any subsidy offered to farmers by the County Government in respect to vaccination?

How will the department ensure that local leaders are involved in the vaccination activities across the County?
