- i. Can the County department of Finance & Economic Planning confirm that these projects were in the 2023/24 FY Budget, and if yes, confirm that the projects were not implemented?
- ii. If the aforementioned projects were not implemented, can the department give reasons why they were not included in the 2024/25 FY Budget?
- iii. What measures will the department put in place to ensure that projects are not lost during the implementation stage?

THAT, health is a fully devolved function with mandate to address all matters health for a healthy county and society.

The construction of Kongkor dispensary which serves the entire Kapau and Akoret locations was allocated Kshs 6.9 million in the 2017/2018 FY. The construction commenced in 2018, stalled in the year 2020 when the contractor's services were terminated by the County Government. In the year 2024 another contractor was awarded the job to construct this dispensary. But, this contractor is yet to begin work as he/she has not been handed over the site. This dispensary was allocated Kshs 4.2 million in the 2024/2025FY through public participation.

- i. When will the new contractor be handed over the site to commence works on the dispensary?
- ii. What are the contract terms for the new contractor, the contract sum, scope of works and completion timelines for the new contractor?
- that caused the previous contractor to be terminated is avoided when dealing with the new contractor so that the construction works can be completed expeditiously and within the contract timelines this time round.

Nurses of three dispensaries within Tirioko Ward were recalled and reposted. The nurse of Kamurio dispensary was recalled in 2023 and reposted elsewhere without a replacement. The nurse for Ptikii dispensary was recalled in 2022 and reposted elsewhere again without replacement. The nurse for Krezee dispensary was recalled in 2024 and for the umpteenth time reposted elsewhere without a replacement.

- i. Why are nurses from the above mentioned stations are recalled and reposted elsewhere without replacements?
- ii. Two of the said dispensaries (Kamurio and Krezee) served two locations each while the third one (Ptikii) served the local school community, a community of more than 10,000 people? What informed the decision to deny all these communities the health services provided by the recalled nurses yet they direly need and deserves these services like other Kenyans elsewhere in this Country?
- iii. What plans has the County Government put in place to ensure that this gross anomaly is corrected and the affected communities and people of Tirioko receive their well deserved health services pursuant to Article 40 of the Constitution and other relevant laws of the land regarding citizen rights?
