**ACKNOWLEDGING THAT**, the County Assembly approves the budget and expenditure of the county government in accordance with Article 207 of the Constitution, legislate as contemplated in Article 220 (2) of the Constitution, guided by Articles 201 and 203 of the Constitution and approve the borrowing by county government in accordance with Articles 212 of the Constitution

**NOTING THAT**, the members of County Assembly while exercising the responsibility bestowed by the people of Kenyan under Article 1(2) to represent the electorate are duty bound to ensure that the electorate get adequate services,

**FURTHER NOTING THAT**, there are sectoral committees established under the County Assembly Standing Orders responsible for oversighting respective corresponding county departments,

**CONCERNED THAT**, there have been soaring levels of roll over due to low absorption rates coupled with delay in projects implementations as shown by periodic financial reports,

**NOW THEREFORE**, this Motion urges this House to resolve that all sectoral committees:

1. Must look into the implementation of the projects in their corresponding county departments.
2. Confirm and furnish this House with a comprehensive report on the status of each project and what causes the delays on completion of such projects,
3. Furnish this House with a list of roll over projects for each sector, recommend how to end the roll over menace and provide a roadmap on how respective departments intend to speed up the implementation of projects.

## **MOTIONS**

### **8. HON. ELIZABETH KIPSANG – MCA, BARINGO COUNTY**

**AWARE THAT**, the Constitution of Kenya as stipulated under Article 43 (1) (a) provides that every person has a right to the highest attainable standard of health which includes the right to health care services,

**FURTHER AWARE THAT**, Under Article 57, the Constitution obligates the state to take measures to ensure Older Persons' participation, personal development, dignity, respect and protection from abuse; and together with the family, the obligation to provide care and reasonable assistance to Older Persons.

**ACKNOWLEDGING THAT**, older persons especially those having various limitations are living in depilated status where most are left to take care of their own despite their vulnerability,

**NOTING THAT**, there is need to ensure the safety, security and the general well-being of the senior citizens are taken into consideration by the government,

**CONCERNED THAT**, there have been dire reports both in print and electronic media showing the sorry state of living of the elderly persons which has pushed most of them to early deaths due to lack of proper care and protection,

**DISTURBED THAT**, despite the fact that the senior citizens in the County are living in dire conditions there have been no habitable houses to aid their already deplorable conditions,

**NOW THEREFORE**, this Motion urges the County Government to:

- i. Provide or construct safe houses for the elderly persons in each sub county where there are special installations in those houses where panic buttons are in case of emergencies,
- ii. To set aside funds in the Budgetary allocation to ensure there are adequate funds to construct safe houses for the elderly to cater for those who periodically fall into the elderly persons bracket.
- iii. Ensure that the elderly are encouraged to break from the tradition especially those accustomed to the bustling life in towns move into a home where they can spend their sunset years in peace.

**AWARE THAT** Article 188 of the Constitution provides for alteration of county boundary by taking into consideration population density, physical and human infrastructure, historical and cultural ties, cost of administration, views of communities affected, geographical features and objects and devolution of governments;

**ACKNOWLEDING THAT,** Article 10 of the Constitution provides for the promotion of national values and principles of good governance which include human dignity, equity, social justice, inclusiveness, equality and human rights;

**COGNIZANCE** of section 3(b) of the Inter -governmental Relations Act, 2012 which provides for a framework for consultation and cooperation amongst county governments and that county boundaries are highly protected in the 2010 Constitution and that the status quo as at its promulgation must be respected at all times by all stakeholders;

**APPRECIATIVE** of the native English law principle of good neighborliness and acknowledging the fact that land has from time immemorial been a highly emotive issue;

**CONCERNED THAT,** in the recent past, there has been encroachment of areas bordering Ng’elecha, Tandare, Korkoron and Lamaiywe areas in Mukutani and Mochongoi ward-Baringo South Sub-county, posing a threat to peaceful coexistence among the communities which may further spark political tension, disharmony and heightened animosity if the situation is not addressed at the earliest instance;

**DISTURBED THAT** recently, unknown surveyors accompanied by a contingent of security officers were spotted doing survey work and demarcation of land at Ng’elecha, Tandare, Korkoron and Lamaiywe areas in Mukutani and Mochongoi ward respectively within Baringo County;

**NOW THEREFORE;** this Motion urges the County Government of Baringo to:

- 1) Immediately move with speed in conjunction with Laikipia County government and address the encroachment within Ng’elecha, Tandare, Korkoron and Lamaiywe areas in Mukutani and Mochongoi ward respectively and other areas with imminent encroachment within Baringo County Governments boundary.

- 2) Pending intervention by county governments, the surveyors and security agents to desist from conducting any further survey or any similar activities pertaining the aforetasted boundaries.
- 3) Pursuant to Article 188 of the Constitution as read together with part one of the fourth schedule, the national government through IEBC with the approval of the National Assembly and the Senate to undertake independent boundary review between Baringo and Laikipia Counties before the 2022 general elections.
- 4) Engage all leaders (M.C.A's Members of Parliament, Senators and Governors) from both County Governments to amicably resolve the escalating conflicts arising from the boundary disputes.
