- i. If he is aware that during the 2017/2018 Financial Year, ten plastic water tanks of 10,000 litre capacities were budgeted to be bought for ten (10)Tirioko ward ECDE centres?
- ii. If he is further aware that the ten tanks were to be distributed to the following ECDE centres namely:
 - a) Domo ECDE
 - b) Chemayes ECDE
 - c) Dira ECDE
 - d) Kangiruru ECDE
 - e) Kreze ECDE
 - f) Chischis ECDE
 - g) Katagh ECDE
 - h) Loyamoi ECDE
 - i) Chepkirial ECDE
 - j) Kamurio ECDE
- iii. Can the Chairperson confirm if the said tanks actually reached the intended ECDE centres?
- iv. Can the Chairperson without the use of signed list from the department table before this Honourable House the acknowledgment and or receipt letters of the said tanks from each of the intended ECDE centres with photographical evidence on the availability of the said tanks in each of the listed centres?

v. What measures is the County Government taking to ensure that the said tanks are availed to the respective ECDE centres?

(The Public Accounts and Investments Committee to investigate further and deliver the thirteen (13) tanks by all means and recommend surcharging of the persons found culpable. The report to be tabled in three (3) weeks' time)

- i. If she is aware that Community-Based Organizations (CBOs) are non profit, organizations on a local and national level, facilitating community efforts for community development in various areas including health, micro-finance, and education among other initiatives aimed at improving the livelihoods of the people of Baringo County?
- ii. How many CBOs are registered in the County and what is their physical location, scope of activity and their current Status (active or inactive)?
- iii. What is the relationship between the County Government and the said CBOs in ensuring that the CBOs through their unique scope and mandate effectively and efficiently serve the people of Baringo County?

8. MOTION

AWARE THAT, Article 1(1) of the Constitution of Kenya 2010 vests all sovereign power in the Kenyan people which is to be exercised either directly by the people through public participation or indirectly through their democratically elected representatives,

FURTHER AWARE THAT, citizen participation was made a national value and a principle of public service in Articles 10(2a) and 232(1) of the Constitution and mandatory through section 115(1) & (2) of the County Government Act, 2012,

ACKNOWLEDGING THAT, Section 115 (2) of County Governments Act states that each County Assembly shall develop laws and regulations giving effect to the requirement for effective citizen participation in development planning and performance management within the county and such laws and guidelines shall adhere to minimum national requirements,

NOW THEREFORE, this motion prays;

- 1. **THAT**, the pre-budget public participation process starts at the sub-locational level and culminates at the ward level.
- 2. **THAT**, the ward level Budget Committee be drawn from selected representatives from sub-Location level.
- 3. **THAT**, the public participation participants at ward level, selected from the sub-locational level be facilitated with transport reimbursement.
