THAT, this House **adopts** the Report of the Finance and Economic Planning Committee on the Baringo County Government Second Quarter Budget Implementation Report for the 2020/2021 Financial Year

AWARE THAT, the Constitution of Kenya provides that service delivery to the people is of paramount importance and as such the same shall be devolved to the smallest units that is the villages,

FURTHER AWARE THAT, International Human Rights Charters provide that all persons are equal and thereby entitled to their rights as stipulated under Chapter Four of the Constitution,

ACKNOWLEDGING THAT, Section 80 of the Public Procurement and Disposal Act provides for a determination of qualified persons in any procurement processes,

NOTING THAT, there have been perennial delays in the procurement processes in the County Government leading to payment delays to the contractors undertaking activities within the County,

NOW THEREFORE, this Motion urges the County Government to:

1. Devolve the procurement department in the County such that every department must have its own procurement department to enable seamless procurement activities within the County

- i. If she is aware that Community-Based Organizations (CBOs) are non profit, organizations on a local and national level, facilitating community efforts for community development in various areas including health, micro-finance, and education among other initiatives aimed at improving the livelihoods of the people of Baringo County?
- ii. How many CBOs are registered in the County and what is their physical location, scope of activity and their current Status (active or inactive)?

- iii. What is the relationship between the County Government and the said CBOs in ensuring that the CBOs through their unique scope and mandate effectively and efficiently serve the people of Baringo County?

004/2021: Hon. Charles Koske, MCA, Mogotio Ward, seeks a statement from the **Chairperson, Environment and Natural Resources Committee** on the following matters of great concern:

- i. If he is aware that liquor glass bottles and glass waste are usually thrown away indiscriminately by users posing a health hazard in urban and rural trading centres in Baringo County?
- ii. Is he aware that there is no dump site in Mogotio town?
- iii. If he is further aware that children break the carelessly disposed of bottles and glasses as part of their play further exposing the public to the danger of stepping on the broken bottles and broken glasses or causing damage to their motor vehicles?
- iv. Is he aware that currently members of the public are exposed to great danger by thousands of broken bottles and broken glasses strewn all over our urban centres due to reckless disposal of used glass bottles and broken glasses?
- v. Is there a policy for safe disposal of used glass bottles and used or broken glass to protect members of the public from exposure to broken bottles or broken glass in Baringo County?
- vi. What measures has the County Government put in place to ensure that members of the public are not exposed to the danger posed by broken glass bottles or broken glass and that there is a specific policy in place to deal with glass waste and that dump sites are available in all market centres and towns across the County including Mogotio town?
