- i. If she is aware that Community-Based Organizations (CBOs) are non profit, organizations on a local and national level, facilitating community efforts for community development in various areas including health, micro-finance, and education among other initiatives aimed at improving the livelihoods of the people of Baringo County?
- ii. How many CBOs are registered in the County and what is their physical location, scope of activity and their current Status (active or inactive)?
- iii. What is the relationship between the County Government and the said CBOs in ensuring that the CBOs through their unique scope and mandate effectively and efficiently serve the people of Baringo County?

005/2021: Hon. Paul Serem, MCA, Lembus-Perkerra Ward, seeks a statement from the **Chairperson Transport, Public Works and Infrastructure Committee** on the following matters of concern:

- i. If he is aware that the County Government has over time acquired plants, machinery and equipments?
- ii. Can the chairperson provide the House with an inventory of each and every one of these plants, machines and equipments including their buying price, date of purchase and current state?
- iii. What measures have been put in place by the County Government to ensure that the said assets are publicly disposed of once rendered obsolete or not in

serviceable condition and when shall the unusable ones be disposed of in this plan?

008/2021: Hon. John Tarus, MCA, Sacho Ward, seeks a statement from the **Chairperson Lands, Housing and Urban Development Committee** on the following matters of concern:

- i. If he is aware that cemeteries have been set aside by the County Government?
- ii. How many of such public cemeteries have so far been set aside?
- iii. What is the acreage of each of them?
- iv. Is he aware that some of the land parcels set aside for public cemeteries have been grabbed by private developers?
- v. How many of the land parcels set aside for public cemeteries have been grabbed as alleged and what acreage is each of the grabbed parcels?
- vi. What plans has the County Government put in place to ensure that the parcel meant for public cemeteries but have been grabbed are reposed and put to the intended use?
- vii. What plans are there to acquire more land parcels for public cemeteries bearing in mind that those so far acquired are inadequate?

- iv. What measures has the Department of Lands, Housing and Urban Development put in place to ensure that all market centres and towns in the County have been properly demarcated, planned and classified accordingly?

- iv. Whether the above mentioned Counties have the original maps for the area mentioned.
- v. What measures will the concerned County Governments put in place to ensure that the borderlines and community rights of the said communities are observed in the course of pursuing development?

- iii. How many are they (give the number and the type of the plants/machines) per County, Sub-County and Ward respectively.
- iv. Giving the reasons in each case, how many of these plants/machines are not working?
- v. If he is further aware that there are dozers, excavators, Lorries and other machineries that are not serviceable but they have been left unserviced for many years?
- vi. Is there any regulation in place to operationalize these machineries?
- vii. What plans has the department put in place to make sure that the plants/machines are in good condition to offer services to the people of Baringo?
- viii. Are there operators permanently employed or on contract to operate these plants/machines?
- ix. Give the list of the operators, their years and terms of service?
- x. For how long have they remained unpaid?
