- i. If he is aware that during the 2017/2018 Financial Year, ten plastic water tanks of 10,000 litre capacities were budgeted to be bought for ten (10)Tirioko ward ECDE centres?
- ii. If he is further aware that the ten tanks were to be distributed to the following ECDE centres namely:
 - a) Domo ECDE
 - b) Chemayes ECDE
 - c) Dira ECDE
 - d) Kangiruru ECDE
 - e) Kreze ECDE
 - f) Chischis ECDE
 - g) Katagh ECDE
 - h) Loyamoi ECDE
 - i) Chepkirial ECDE
 - j) Kamurio ECDE
- iii. Can the Chairperson confirm if the said tanks actually reached the intended ECDE centres?
- iv. Can the Chairperson without the use of signed list from the department table before this Honourable House the acknowledgment and or receipt letters of the

said tanks from each of the intended ECDE centres with photographic evidence on the availability of the said tanks in each of the listed centres?

- v. What measures is the County Government taking to ensure that the said tanks are availed to the respective ECDE centres?

- ii. How many CBOs are registered in the County and what is their physical location, scope of activity and their current Status (active or inactive)?
- iii. What is the relationship between the County Government and the said CBOs in ensuring that the CBOs through their unique scope and mandate effectively and efficiently serve the people of Baringo County?

017/2021: Hon. Maureen Cherus, MCA, Baringo County, seeks a statement from the **Chairperson County Heritage, Gender, Culture and Community Services Committee** on the following matters of concern:

- i. If she is aware that Gender Based Violence (GBV) is prevalent in Baringo County?
- ii. If she is also aware that there is a presidential directive to end Female Genital Mutilation in the Country by 2022, and all forms of Gender Based Violence?
- iii. Can she provide this House with information on any strategic or policy intervention regarding such retrogressive practices by the relevant department of Baringo County Government?
- iv. Can she also provide this House with the number of recorded cases of different types of Gender Based Violence (rape cases, child marriages, wife/husband battering, domestic violence, Female Genital Mutilation and any other form of GBV) and from which part(s) of the County such cases have been prevalent?
- v. What plans has the County Government put in place to curb and ultimately bring to an end the ever rising cases of GBV in Baringo County?

CONSIDERATION OF THE BUDGET ESTIMATES OF THE BARINGO COUNTY GOVERNMENT FOR THE FINANCIAL YEAR 2021/2022

(The Chairperson, Budget and Appropriations Committee)

THAT, this House **adopts** the Report of the Budget and Appropriations Committee on the Budget Estimates of the Baringo County Government for the Financial Year 2021/2022, *laid on the Table of the House on the afternoon of Tuesday 4th May, 2021*, and in accordance with the provisions of Article 220 of the Constitution as read together with Section 131 of the PFM Act and Standing Order 212 of the Baringo County Assembly Standing Orders, **approves** -

- i. A total Budget Expenditure of **Kshs 9,808,318,848** to meet the Expenditure during the 2021/2022 FY in respect of the Votes as contained in the attached First (1st) Schedule;
- ii. An increment of Kshs 2,496,762,283 to the total Budget Expenditure of the Baringo County Budget Estimates 2021/2022FY from Kshs 7,309,556,565 to **Kshs 9,808,318,848** in respect of the Votes as contained in the First (1st) Schedule;
- iii. An increment of Kshs 196,094,429 to the Recurrent Expenditure (R.E) of the Baringo County Budget Estimates 2021/2022FY from Kshs 4,906,725,384 to read **Kshs 5,102,819,813** in respect of the Votes as contained in the attached Fourth (4th) Schedule;
- iv. An increment of Kshs 2,302,667,854 to the Development Expenditure (D.E) of the Baringo County Budget Estimates for the 2021/2022FY

from Kshs 2,402,831,181 to **Kshs 4,705,499,035** in respect of the Votes as contained in the attached Fifth (5th) Schedule

Further this House **resolves** that, the Schedules herein attached (First to Sixth Schedules) form the basis of the enactment of the Baringo County Appropriations Act 2021.
