APPROVAL OF THE MEMBERS OF THE COUNTY ASSEMBLY TO SERVE IN THE HOUSE BUSINESS COMMITTEE

(The Leader of the Majority Party)

Mr. Speaker Sir, pursuant to Standing Order 51 (i), I beg to move the following Motion:

AWARE THAT, Baringo County Assembly Standing Orders number 156 states that: *'there shall be a select committee to be designated as the House Business Committee, consisting of the following members':*

- 1) The Speaker as the Chairperson
- 2) Chairperson of Committees (the Deputy Speaker)
- 3) The Leader of the Majority Party
- 4) The Leader of the Minority Party
- 5) Majority Whip
- 6) Minority Whip
- 7) **Not less than Seven and not more than Eleven** other members who shall be nominated by parties represented in the House and approved by the County Assembly at the commencement of every session.

FURTHER AWARE THAT, the membership of this committee shall reflect the relative majorities of the seats held by each of the parties in the House taking into account the interests of the independents.

APPRECIATIVE of the House Business Committee Mandates to include:

- 1) Prepare and, if necessary, from time to time adjust the County Assembly Calendar with the approval of the House;
- 2) Monitor and oversee the implementation of the House Business and Programmes;
- 3) Implement the Standing Orders respecting the scheduling or programming of the business of the House and the functioning of the Committees of the House;
- 4) Determine the order in which the reports of Committees shall be debated in the House;
- 5) Take decisions and issue directives and guidelines to prioritize or postpone any business of the House acting with the concurrence of the Leader of the Majority Party or the Leader of the Minority Party, as the case may be, and

- 6) Consider such matters as may from time to time arise in connection with the business of the House and shall have and perform such powers and functions as are conferred on and ascribed to it by these Standing Orders or from time to time by the House.
