**FURTHER AWARE THAT**, upon its approval, the Hon. Speaker directed the Committee on Selection to proceed to a report writing session and constitute membership to various House Committees as envisaged in Standing Order number 157 (2).

**ACKNOWLEDGING THAT**, Baringo County Assembly Standing Orders number 157 states that: *'there shall be a select committee to be designated as Committee on Selection, consisting of the Leader of the Majority Party who shall be the Chairperson, the Leader of the Minority Party, not less than five and not more than seven Members, who shall be nominated by County Assembly Parties and approved by the House'*.

**FURTHER RECOGNIZING** the mandates of Committee on Selection as per Standing Order 159 as follows:

- i. The Committee on Selection shall nominate Members to serve in Committees, save for the membership of the House Business Committee and Committee on Appointments.
