7. STATEMENTS

009/2024: Hon. Hon. Sharon Keter, MCA, Baringo County seeks a statement from the **Chairperson, Transport, Public Works and Infrastructure Committee** on the following matters of concern:

That Article 183 of the Constitution as read together with sections 36 of the County Governments Act spells out the core functions and mandates of a County Executive Committee Member to include managing and coordinating the functions of county administrative departments among others;

Pursuant to the above:

- 1. Has the C.E.C.M for Transport, Public Works and Infrastructure formulated policies and or guidelines relating to management of public works equipment, machinery and personnel?
- 2. On supervision and on prompt delivery of services, has the said C.E.C.M formulated an Asset Disposal Policy procedure and any other relevant law and or policy to enhance efficient service delivery in his department?
- 3. On recruitment of drivers, what efforts and or measures has the C.E.C.M taken to date to ensure recruitment of drivers in acting capacity or those on contractual terms to improve on service delivery?
- 4. On the issue of wastage of public resources, what measures has the C.E.C.M taken on alleged loss of fuel to a tune of Kenya shillings 25 million and what future plans does he have to avoid recurrence of the same issue and ensure the departments' operations are streamlined?

012/2024:.SymonKiplagat, MCA, Kabartonjo Ward seeks a statement from the **Chairperson of Water and Irrigation Committee** on the following matters of concern:

That Kabartojo ward has been grappling with widespread water scarcity/ shortage owing to inadequate water distribution for some time now thus threatening the livelihoods of the residents of Kabartonjo

- 1. What plans does the department have in place to ensure adequate distribution and provision of water in Kabartonjo town and its surrounding?
- 2. What plans does the department have pertaining inadequate personnel or staff dealing with water in Kabartonjo town?
- 3. What measures has the department put in place for the recruitment of a substantive officer in charge of water services in Kabartonjo town as the current one stays in Kabarnet.
- 4. What plans does the department have in place to ensure that there is a proper sewerage system in Kabartonjo town?

013/2024: Hon. Symon Kiplagat, MCA, Kabartonjo Ward seeks a statement from the Chairperson, Environment and Natural Resources Committee on the following matters of concern:

Since inception of devolution, Baringo North Sub County has been struggling with improper sewage/waste management which poses a serious threat to the environment and human health.

- 1. Are there county policies in place on solid waste management as it poses a major challenge to the growing urban population.
- 2. What measures has the department put in place to ensure that there is designated waste disposal /public dump site for use by the residents in the entire county?
- 3. Is there public land designated for such use, if so, where? If not, what plans does the department have on this issue?
- 4. Are there designated garbage collection lorry/trucks, huge trash bins and exhaust services in the town to collect all forms of garbage/waste?
- 5. How many skilled personnel are in place to offer this much needed services in Kabartonjo town and the entire county?
- 6. Apart from Kabartonjo, what plans does the department have to ensure that the solid waste management in the entire county is streamlined?

017/2024: Hon. Hon. Linah Sote MCA, Baringo County seeks a statement from the **Chairperson, Transport, Public Works and Infrastructure Committee** on the following matters of concern:

That Kabarnet Airstrip is a County facility under the transport Public works and infrastructure department;

That the County has for a long time not utilized the facility to its full potential and the facility has been left in a bad state.

That the road leading to the facility from Cifika hotel is also in a very bad state with a lot of potholes and bushes, pausing danger to both motorists and pedestrians.

Pursuant to the above:

- 1. What measures does the Department have to ensure that the airstrip is fully renovated and utilized?
- 2. What plans does the Department have for the repair of the said road and clearing of the bushes?
- 3. What plans is the County Government putting in place to ensure that the airstrip improves Trade and Tourism in the County considering Baringo was internationally recognized as a Geopark site?
