- ii. Are you aware that some ECDE centers have no teachers posted by the County Government as required by the law, forcing parents to employ and contribute for their monthly pay?
- iii. Are you also aware that some ECDE centres in Marigat ward lost their teachers due to natural attrition or change of service for example-koriema, Illiagat, Kimao and Sereton among others and they have not been replaced?
- iv. Why have those centres whose positions fell vacant have not been replaced yet they were in payroll, what happened with their budget?
